Call to Order - Chairman Houston called the regular session meeting to order at 6:00pm.

Member Saunders made the motion for the title of Managing Director be eliminated and Re-Titled to Airport Manager for hiring, hiring advertisement, and position description. Member Siemens seconded the motion, and the motion carried 6-0.

Chairman Houston requested an ADHOC committee to include himself, Member Siemens, and Member Saunders in preparation for hiring new management.

<u>Projects Update:</u> Mr. Gruebel provided the board a letter for review on Essential Facilities during the COVID-19 restrictions in the State of North Carolina for discussion. He also provided a Runway 1-19 update from the January 19<sup>th</sup> meeting he and Mr. Olson had with the Coast Guard for the project. Per Captain Meador it was a very positive meeting and the methodology was agreeable by all.

<u>Chairman's Report</u> - Chairman Houston requested a motion to approve a transfer of \$20,000 from interest accumulated in the investment fund to the Airport operating account.

Member Saunders made the motion to transfer \$20,000 in accumulated interest into the Airport operating funds. Member Caudle seconded the motion, and the motion carried 6-0.
